SUBJECT: Approval of Resolution R-25-08 in favor of grant funding for Fletcher sewer project.



Background:

The Town is applying for state revolving funds from the North Carolina Department of Environmental Quality (DEQ). The project would provide funding for a sewer extension project to Westfield Road, North Hudson Lane, and Dogwood Terrace. A resolution is required from the governing board to authorize submission of the application.

RESOLUTION BY GOVERNING BODY OF APPLICANT

WHEREAS, The Town of Fletcher has need for and intends to construct, plan for, or conduct a study in a project described as Fletcher Sewer Project, and

WHEREAS, The Town of Fletcher intends to request State loan and/or grant assistance for the project,

NOW THEREFORE BE IT RESOLVED, BY THE FLETCHER TOWN COUNCIL OF THE TOWN OF FLETCHER:

That **Town of Fletcher**, the **Applicant**, will arrange financing for all remaining costs of the project, if approved for a State loan and/or grant award.

That the **Applicant** will provide for efficient operation and maintenance of the project on completion of construction thereof.

That the **Applicant** will adopt and place into effect on or before completion of the project a schedule of fees and charges and other available funds which will provide adequate funds for proper operation, maintenance, and administration of the system and the repayment of all principal and interest on the debt.

That the governing body of the **Applicant** agrees to include in the loan agreement a provision authorizing the State Treasurer, upon failure of the Town of Fletcher to make a scheduled repayment of the loan, to withhold from the Town of Fletcher any State funds that would otherwise be distributed to the local government unit in an amount sufficient to pay all sums then due and payable to the State as a repayment of the loan.

That Mark E. Biberdorf, Town Manager, the **Authorized Representative** and successors so titled, is hereby authorized to execute and file an application on behalf of the **Applicant** with the State of North Carolina for a loan and/or grant to aid in the study of or construction of the project described above.

That the **Authorized Representative**, and successors so titled, is hereby authorized and directed to furnish such information as the appropriate State agency may request in connection with such application or the project: to make the assurances as contained above; and to execute such other documents as may be required in connection with the application.

That the **Applicant** has substantially complied or will substantially comply with all Federal, State, and local laws, rules, regulations, ordinances, and funding conditions applicable to the project and to Federal and State grants and loans pertaining thereto.
